**COMMITTEE STUDIES** Requests the House  
Committee on Health and Welfare and the Senate

Committee on Health and Welfare to function as a joint committee to study childhood obesity in the state

- HCR 69 WILLIAMS COMMITTEE STUDIES** Requests the House Committee on Health and Welfare and the Senate Committee on Health and Welfare to function as a joint committee to study autism spectrum disorders
- HB 366 KATZ MEDICAID** Expands Medicaid eligibility to former foster children who have reached adulthood
- HB 466 RICHARD ENVIRONMENT/HEALTH** Amends an exception to the La. Smokefree Air Act which allows smoking in certain areas of nursing homes
- HB 799 BALDONE HEALTH CARE/FACILITIES** Requires prostheses, orthoses, prosthetic services, and orthotic services which are purchased by a state agency or reimbursed by Medicaid to be provided by an accredited facility
- HB 895 GREENE HEALTH CARE/RECORDS** Provides relative to certification of completeness of health care records
- HB 1098 KATZ HEALTH CARE/PROVIDERS** Provides for home and community-based service providers
- HB 1245 LAFONTA HEALTH CARE** Extends the termination date of the Louisiana Commission on HIV, AIDS, and Hepatitis C
- HB 1384 MARCHAND PHYSICIANS** Provides for the licensure of physicians practicing telemedicine
