- SB 340 THOMPSON HEALTH CARE** Provides for the use of electronic signature authentication and identification with respect to individually identifiable health information. (gov sig)
- SB 379 THOMPSON HOSPITALS** Provides for the Rural Hospital Regulatory Impact Relief Act. (gov sig)
- SB 423 CRAVINS, JR. LAW ENFORCEMENT** Creates the missing senior citizen and person with development disabilities alert program known as the "Silver Alert." (8/15/08)
- SB 553 MOUNT MENTAL HEALTH** Provides for a common reimbursement methodology for community mental health centers and community mental health clinics. (8/15/08)
- SB 571 MICHOT HEALTH/HOSPITALS DEPT** Provides for changes to the Louisiana Wholesale Drug Distributors Act. (8/15/08)
