<b>SB 38</b>	<b>GRAY</b>	<b>CHILDREN'S CODE</b> Provides for competency and sanity commissions in juvenile proceedings. (gov sig)
<b>SB 73</b>	<b>GRAY</b>	<b>CHILDREN'S CODE</b> Provides for parental contributions to care and treatment of children in foster care. (8/15/08)
<b>SB 76</b>	<b>GRAY</b>	<b>CHILDREN'S CODE</b> Provides for the restoration of parental rights. (8/15/08)
<b>SB 77</b>	<b>GRAY</b>	<b>CHILDREN'S CODE</b> Adds CASA volunteers to the list of mandatory reporters of child abuse. (gov sig)

- SB 161 JACKSON, L. CHILDREN** Provides relative to income assignment orders. (8/15/08)
- SB 166 MURRAY COURTS** Provides that judges elected in 2009 for the 41<sup>st</sup> Judicial District Court shall automatically revert to the judges of the civil and criminal courts of Orleans Parish should the legislation creating the district be held unconstitutional. (gov sig)
- SB 231 NEVERS TAX/AD VALOREM** Constitutional amendment to lower the age at which the assessment value of residential property is "frozen" from 65 to 62. (2/3 - CA13s1(A))
- SB 260 JACKSON, L. CHILDREN** Provides relative to acknowledgments of judgments and paternity.
- SB 303 LAFLEUR EVIDENCE** Provides relative to introduction of foreign business records in criminal proceedings. (8/15/08)
- SB 416 MURRAY COMMERCIAL REGULATIONS** Enacts the Uniform Unincorporated Association Act. (08/15/08)
- SB 573 MICHOT PROCUREMENT CODE** Clarifies appellate jurisdiction under the Professional, Personal, Consulting, and Social Services Procurement Code. (gov sig)
- SB 574 MICHOT CIVIL PROCEDURE** Authorizes judicial review of a district court decision involving actions by or against the state in connection with contracts. (gov sig)
- SB 624 MURRAY COURTS** Requires a separate environmental docket for the civil district court for the Forty-First Judicial District. (1/01/09)
