SB 10	LAFLEUR	LOCAL OFFICIALS Provides for appointment of the chief of police of the village of Turkey Creek. (8/15/08)
SB 54	MURRAY	EXPROPRIATION Constitutional amendment to remove certain restrictions on the disposition of blighted property expropriated in the city of New Orleans.
SB 72	CROWE	PUBLIC CONTRACTS Authorizes the city of Slidell to enter into design-build contracts.

- SB 98** **MURRAY** **SPECIAL DISTRICTS** Provides relative to French Quarter-Marigny Historic Area Management District. (8/15/08)
- SB 132** **MURRAY** **PARKS** Provides for audit concerning New Orleans City Park, the New Orleans City Park Improvement Association, and its board and provides for the respective responsibility of the park, the association, the board, and the Department of Culture, Recreation and Tourism relative to such audits. (7/1/08)
- SB 224** **SHEPHERD** **HOUSING** Requires that the board of each housing authority include at least one tenant. (Gov sig)
- SB 396** **HEBERT** **PUBLIC CONTRACTS** Provides for certain restrictions for local governments contracting with private companies for a fee or contingency basis. (6/1/08)
- SB 444** **HEBERT** **INSURERS** Adds Louisiana Insurance Guaranty Association to the exempt status for appeal bonds. (8/15/08)
- SB 448** **SHEPHERD** **LOCAL AGENCIES** Authorizes the New Orleans Sewerage and Water Board to require those whose contract with it to repair a water supply system or sewerage system to have a certified Class IV person on the job site. (Gov sig)
- SB 681** **DUPLESSIS** **SPECIAL DISTRICTS** Create the New Orleans East Advisory Neighborhood Commission. (8/15/08)
- SB 687** **DUPLESSIS** **SPECIAL DISTRICTS** Provides relative to the New Orleans Regional Business Park. (Gov sig)
- SB 693** **SHEPHERD** **MUNICIPALITIES** Creates and provides for the River Front Alliance Advisory Neighborhood Commission. (8/15/08)
- SB 696** **ERDEY** **SPECIAL DISTRICTS** Increases the per diem of the board of commissioners of Livingston Parish Recreation District No. 2. (8/15/08)
